*Meeting the Highest Standards*

The Ohio Department of Education has awarded the St. Augustine Manor Child Enrichment Center a two-star rating (out of 3) as part of the Step Up to Quality Program. Out of the approximate 800 centers in Cuyahoga County, only 23 (including ours) has a 2-Star rating. Ratings are based on numerous criteria such as the educational content is aligned with the Ohio Early Learning Content Standards, current education level of staff, continued specialized training, and developmental screenings of students.

In addition, St. Augustine Manor earned a deficiency-free annual survey by the Ohio Department of Health. The Ohio Department of Health conducts unannounced on-site inspections to all licensed facilities every nine to fifteen months.

A team of surveyors spent a week assuring that the facility was in compliance with all 372 State and Federal regulations – the most regulated industry next to nuclear power. The annual survey consisted of a review of all facets of the operation over the past year including environmental and documentation review, observation of care and services provided, interviews with staff, residents and families, and a fire safety review. Surveyors review random resident charts from throughout the past year in addition to personnel files to ensure complete and on-going educational compliance by staff. The annual survey reflects efforts of the entire year.

*Rise Up!*

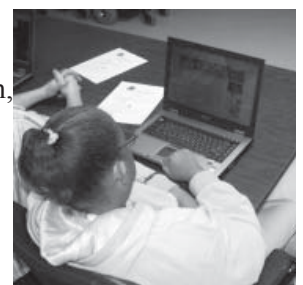
These are familiar words for Cavs fans during the 2007 NBA playoffs. At St. Augustine we live these words each day as we:

# President's Message



Dear Friends,

Challenges are always present. This is especially true when maintaining a Mission to serve some of the most vulnerable – the sick and the elderly- and to provide that service in the city where those in need have access to care.

Cuts in government reimbursements continue to be our biggest challenge and impacts everything from staffing recruiting and retention to resident programs and services.

The current proposed budget cuts an additional 1.75% in 2007 on top of the 2% cut in 2006. Over the past five years these continual budget cuts in addition to increasing inflation amounts to \$51 a day loss for each Medicaid patient, totaling \$2.8 million of unreimbursed cost in fiscal year 2007 and \$3.3 million of unreimbursed cost in fiscal year 2008.

However, in spite of tremendous challenges, we are committed to the individuals we serve each day. As advocates for the sick and elderly, we cannot turn our backs or give-in to the challenges.

As you will see, St. Augustine Health Campus continues to grow and thrive - to redefine itself. Together we address the needs, overcome the obstacles and go above and beyond in the services we provide.

Thanks to generous donors, dedicated staff and selfless volunteers, St. Augustine Health Campus is able to improve services, update vital equipment, enhance the living environment and provide opportunities to honor and reward staff.

Our Vision is to promote the sacredness of lie in a community that celebrates purpose, individuality companionship and well-being. Thanks to all who make this vision a reality everyday through acts of kindness, love and generosity.

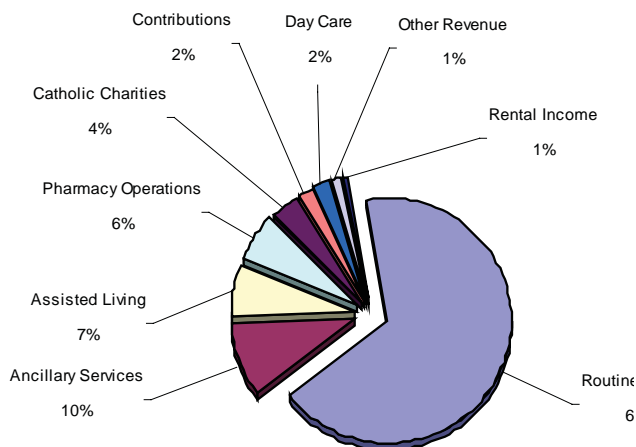


# Financial Report

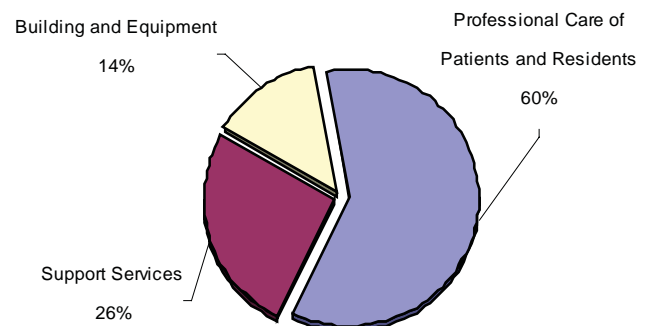

## New IRA legislation results in tax benefits for charitable giving!

On August 17, 2006 the President signed the new pension bill that also permits IRA charitable rollovers. Now, those over 70½ are eligible to transfer money directly from your IRA to St. Augustine Health Campus on a tax-free basis for the 2007 tax year only. To benefit from this regulation transfers must be an outright gift which goes directly from your IRA to St. Augustine Health Campus – and the best part is that your IRA gift is made tax-free!

## The Gift of Stock Appreciated

Stock is almost always a more tax-wise way to contribute than cash. Stock gifts save in two ways: You receive an income tax deduction for the full market value of the stock, and avoid paying the capital gains taxes that would be due on the appreciated portion of the stock’s value if you sold it. To avoid gains taxes, the stock must be held long-term, which generally means more than a year. If you own stock or other investments that have decreased in value since you acquired them, you could sell them and donate the cash proceeds. The loss you incur may also be deductible from other income for more tax savings. The combination of the two deductions could actually be higher than the current value of the investment.
